INTRODUCTION

This Privacy Policy provides information about how WAVE Eye Care, which includes WAVE Contact Lenses®, EyePrint Prosthetics, and Advanced Vision Technologies (AVT) (collectively "we," "us" or "our"), may collect and use information about you when you use the Site. This Privacy Policy applies only to the Site and not to third-party websites, products, services, or applications (collectively, "Third-Party Sites or Services") to which we may provide links. The collection and use of your information by Third-Party Sites or Services are governed by third-party privacy policies, which we are not responsible for. If you link to, enter, download, or provide information to or through any Third-Party Sites or Services, the use and collection of your information by the applicable third-party will be governed by that third-party's privacy policy.

1. INFORMATION COLLECTION

We collect and store two kinds of information related to you:

- Personally Identifiable Information (PII): PII includes any information that identifies or
 could be used to uniquely identify, contact, or locate you. We collect your PII when you
 register with us, create a customer account, purchase products from our online shop,
 participate in interactive features such as providing reviews, comments, survey
 responses, or correspondence with us, and obtain promotional material from us.
- Non-Personally Identifiable Information (Non-PII): Non-PII is information that does
 not uniquely identify you as a person, including PII that has been rendered anonymous.
 We collect Non-PII when you access the Site, such as your IP address, browser type,
 operating system, the third-party website from which your visit originated, how you use
 the Site, including the pages you visit, and the duration of your visits.

2. USE OF INFORMATION COLLECTED

We may use PII and Non-PII to:

- Provide, improve, and personalize the Site and services.
- Respond to your inquiries and requests.
- Better understand your needs and preferences.
- Improve our products, services, and customer experiences.

We may disclose PII and Non-PII to:

• **Third-party Service Providers**: We share information with trusted service providers who help us operate the Site, process transactions, and deliver products and services

(e.g., hosting, data management, analytics). These providers are obligated to protect your information and use it only for the purposes for which it was provided.

- Publicly-Posted Content: If you choose to post reviews, comments, or other information publicly on the Site (e.g., message boards, forums), such content may be visible to other users.
- With Your Consent: We may share your information with third parties if you explicitly consent.

Additionally, we may use Non-PII to analyze Site traffic, identify trends, and better understand customer needs

3. COOKIES

We, and third parties we authorize, may use cookies and similar technologies to collect Non-PII automatically. Cookies are small files placed on your device to help recognize your browser and improve your experience. You can manage cookies through your browser settings, but note that disabling cookies may limit some functionality of the Site.

We use industry-standard security measures to protect your information during transmission and storage, including secure servers, encryption, and controlled access. While we strive to protect your PII, no method of transmission over the internet is 100% secure, and we cannot guarantee absolute security.
